In 2012 local communities in England received the right to participate in one of the most important and significant powers of local government: namely, the power to establish a Neighbourhood Development Plan that will have equal legal status with the local authority's Local Plan once it has passed a referendum and been formally adopted by the local planning authority. The adopted Neighbourhood Development Plan has legal weight in decision making on planning matters, unlike non-statutory tools such as parish plans. Now, for the very first time you have an opportunity to have a real say in how our local area should develop. The future of our Parish really is in our hands!

This Questionnaire provides you the opportunity to express your views and influence the future development of our Parish. Other community consultations will be held as preparation of the Neighbourhood Development Plan progresses. We are inviting everyone aged 18 and over to express their opinions on a range of issues by replying to the Questionnaire. Evidence from this Questionnaire will be used to help develop the **Middleton-on-Sea Neighbourhood Development Plan. The Plan will contain policies and strategies to guide the development of the Parish up to the year 2040.**

Why have a Neighbourhood Plan?

As part of the Arun District Council Local Plan decisions will be made about the numbers of new houses to be built. The Arun District Council Local Plan will provide the number of houses in our Parish to be built and the Parish Council will decide if this number is fair.

The Local Plan will also contain policies on other aspects of land use in the Parish, such as for employment, roads and transport, recreation and a range of community uses. Further policies will deal with the environment, heritage and protection of wildlife areas.

The focus of the planners is very much towards the urban area, but what is appropriate for the urban area is not necessarily appropriate for the setting of the coastal rural area, its communities and its economy. It is therefore very important for us to have a Neighbourhood Development Plan that sets policies that are appropriate for our Parish and coastal rural context.

What a Neighbourhood Development Plan will do

A Neighbourhood Development Plan will assist in guiding the way the Parish is developed. It will ensure that the character of the Parish is respected while any development is beneficial to the local community and makes a positive contribution to the local economy. If our community is to thrive it is essential that local matters receive the necessary attention they deserve by District Planning. The Arun District Council Local Plan will always have a more strategic focus over the whole area of Arun District and beyond.

Our Plan can set policies for where new houses may be built, for the size and type of developments and the design of dwellings. This will help to ensure that houses are built in the places where the community feels they will be most beneficial. It will enable us to control the appearance of new developments and ensure that they respect and blend in with the rural character of what already exists.

A Neighbourhood Development Plan will enable us to identify and plan for the facilities and services that are needed by our growing and changing population. We need to identify our needs in terms of shopping, recreation, sport, leisure, facilities for local businesses, transport, road safety, and our coastal rural environment and heritage. The completed Neighbourhood Development Plan must be approved in a Neighbourhood Referendum. If it receives approval it will be adopted by Arun District Council and become part of the Local Plan. It will have legal standing and planning officers will have to refer to the Neighbourhood Development Plan's policies when deciding planning applications.

Why a questionnaire?

The success of the Neighbourhood Development Plan will depend on the participation of the community and help to identify issues facing the Parish. This questionnaire is designed to elicit your opinions on some of the important issues that must be considered as we plan for the development of our Parish. By identifying needs and planning to meet them we can plan for a healthy, vibrant local community and economy; and we can plan for growth and change that do not conflict with the coastal rural environment and landscape that we all love and that are the reason why so many of us came to live here.

The Neighbourhood Development Plan provides an opportunity for residents to influence future housing development in the parish. Therefore the following questions ask you to consider:
